Declaration of consent under data protection law in the context of the childcare service KIDS @ EXPO REAL 2025

The processing of all personal data transmitted to us takes place exclusively within the framework of the statutory provisions of data protection law. All the following data protection terms correspond to the definitions in Art. 4 GDPR.

Controller and data categories

The controller responsible for data processing within the meaning of data protection legislation is Events4Kidz GmbH, Bürgermeister-Wild-Straße 35, 85521 Ottobrunn (hereinafter referred to as Events4Kidz). Subject matter of data protection/data categories

The subject matter of data protection is the processing of personal data. This is any information relating to an identified or identifiable natural person (data subject). Master data: in particular your surname, first name (e.g. last name, first name) and date of birth of your child/children.

Contract data: in particular data that you provide to us to fulfill the contract.

Content data: in particular data that is exchanged between us in the course of correspondence.

We process personal data in compliance with the relevant data protection regulations. This means that your data will only be processed by us with your consent.

Purpose of processing

Events4Kidz processes personal data for the following purposes: Organization of the EXPO REAL childcare program. The processing of your personal data in this context is carried out on the basis of Art. 6 para. 1 lit. b) GDPR, insofar as it is necessary for the aforementioned purposes.

Retention periods/fulfillment of legal obligations

Based on your consent, personal data will be stored for a maximum of two years, unless longer storage is necessary to fulfill the purpose for which the data was collected or to fulfill legal retention obligations (e.g. commercial and tax retention obligations). In this respect, data processing is carried out on the basis of Art. 6 para. 1 lit. c) GDPR. We delete the data once the legal obligation no longer applies.

Recipients

Events4Kidz only passes on personal data to external third parties if this is necessary for the execution of the contract or if legal permission has been granted. In this case, the transfer takes place on the basis of Art. 6 (1) a), b), c) and/or f) GDPR. External recipients may also be service providers that we commission to provide services as part of order processing in accordance with Art. 28 GDPR (e.g. tax consultants, data center operators and other IT service providers). In addition, personal data may be transferred to authorities and state institutions for legally compelling reasons, e.g. to customs authorities

I hereby consent to the collection and processing of my personal data within the scope and for the purposes stated above.

I am aware that the declaration of my consent is voluntary and that I have the right to revoke it at any time with effect for the future. For this purpose, it is sufficient to send a message to Mail: hallo@events4kidz.com. In the event that consent is revoked, Events4Kidz may only further process your personal data if there is another legal basis for doing so.

Right to information, correction, deletion or restriction of your personal data, right to object and right to data portability

Under applicable data protection law, you may have the right:

- i. request confirmation as to whether Events4Kidz is processing personal data about you and to receive information about the personal data processed by Events4Kidz and further information,
- ii. request the correction of inaccurate personal data,
- iii. request the erasure of personal data processed by Events4Kidz, iv. request the restriction of the processing of personal data by Events4Kidz,
- iv. request the erasure of personal data processed by Events4Kidz, iv. request the restriction of the processing of personal data by Events4Kidz,
- v. object to the data processing of your personal data by Events4Kidz. .

Nappy changing

Nappies will not be changed as part of the childcare services. Caregivers will call the parents/guardians, who must return to the childcare facility to change their child.

Liability insurance

The parents/guardians will be responsible for any damage caused by their children at all times. The parents/guardians' liability insurance shall include the coverage for all damages to personal belongings by their child(ren)'s own carelessness or negligence (for example, a child stumbles and shatters their or another child's spectacles, or a child damages their own or another child's clothes), loss of personal belongings and theft of belongings.

Liability

Except in case of gross negligence or wilful misconduct, Care4Kidz shall not be liable for any damage caused. The parents/guardians agree to indemnify, defend and hold Care4Kidz harmless from and against any and all liability, loss and expense (including attorney's fees) or any claims arising out of or resulting from its activity and/or caused by their child.

Additional information

- It is the parent/guardian's responsibility to provide all important information related to the child (including allergies and special health conditions) when submitting the childcare booking form and to remind the caregiver on site of this information when checking the child into the childcare facility.
- For children with special needs, the childcare service provider reserves the right to decline an application, based on the capacity of the childcare services, on a case-by-case basis.
- The childcare services will not administer any prescription medicine to the children. A parent/guardian must return to the childcare facility to dispense any medicine to the child.
- Parents/guardians must provide a contact number where they can be reached at any time while the child is in the childcare facility. Parents/guardians must be available at any time to change their child or to collect their child from the childcare facility in case any problem occurs with the child in the childcare facility.
- Parents/guardians or any people authorized by the parents/guardians to check child(ren) in and out of the childcare facility must bring their passport or other ID.
